ADDENDUM A - Zoning Map Amendment Process

1

• An application for an amendment, or change, to the Town's Official Zoning Map is filed with the Code Enforcement Office.

2

• Code Enforcement conducts a formal review of the completed application and prepares appropriate mapping and the petition.

3

• The Planning Commission schedules a public meeting to review the zoning amendment application and makes a recommendation to Town Council.

• Publication of a legal advertisement describing the petition for zoning map amendment at least 30 days prior to the scheduled public hearing and notifies adjacent property owners of the proposed zoning amendment.

• City Council hears the petition in accordance with its rules and procedures and makes a determination for approval or denial during the meeting after the public hearing.



APPROVED

If the petition for the zoning map amendment is approved by Town Council, the applicant receives approval and is formally notified by mail and the Official Zoning Map is amended to reflect the approved zoning reclassification.



DENIED

If the petition for the zoning map amendment is denied by Town Council, the applicant is formally notified in writing of the denial and the right to appeal the decision to the Circuit Court of Monongalia County.
